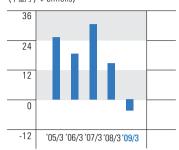

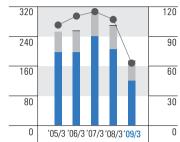

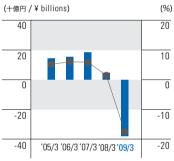

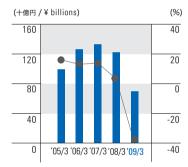

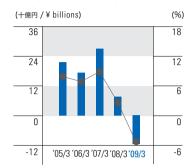

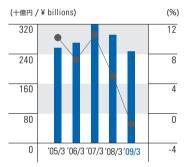

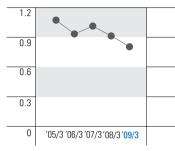
Return on investment ROI

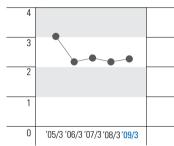
Total assets turnover 総資産回転率

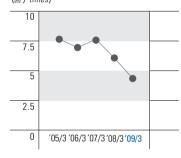
Equity turnover 自己資本回転率

Tangible fixed assets turnover 有形固定資産回転率

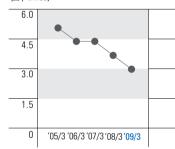

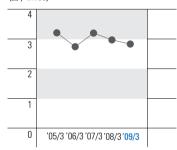

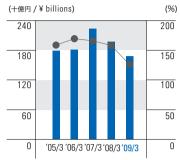

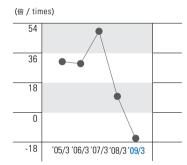


Fixed assets & Fixed asset/liability ratio 固定資産&固定長期適合率

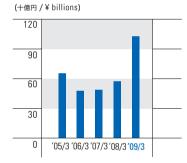

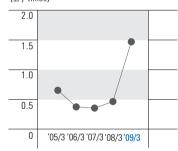

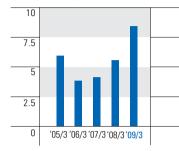

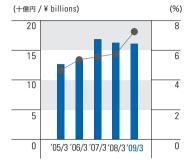


Depreciation and amortization 減価償却費

R&D expenses & R&D/net sales ratio 研究開発費&研究開発費比率

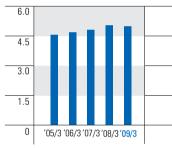

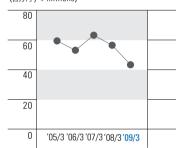

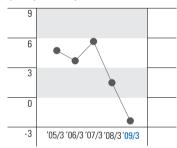
Net sales per employee 従業員 1 人当たり売上高

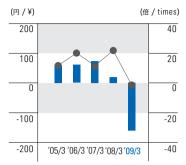

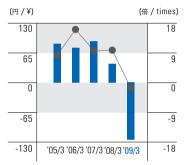

■ 1 株当たり当期純利益 Net income per share PFR

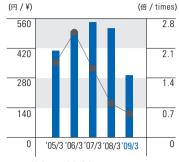
Cash flow per share & Price to cash flow ratio 1株当たりキャッシュ・フロー&PCFR

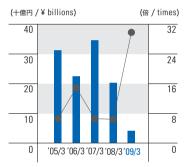
Net assets per share & Price to book value ratio

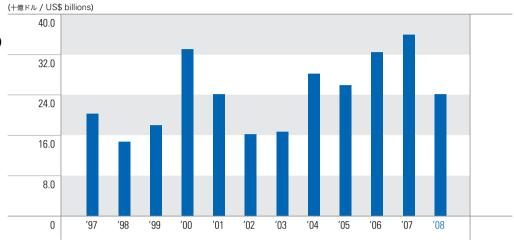

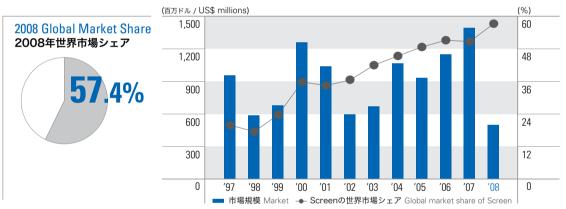

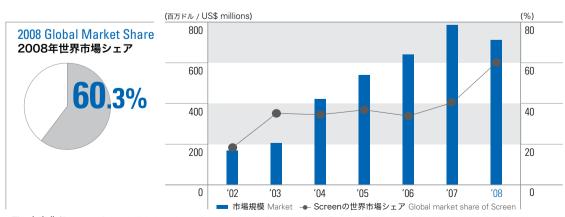

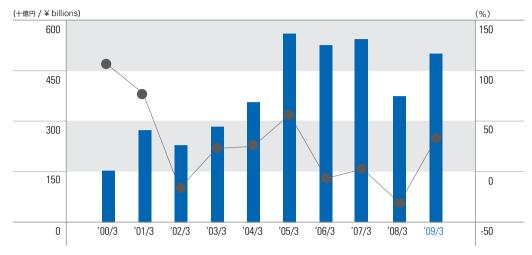

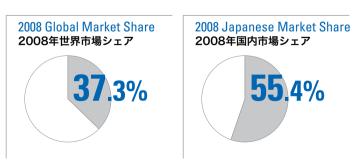
